SCHOOL-PARENT COMPACT

Staff is available to parents by phone and email. If an appointment is needed, parents may schedule time during the teacher's planning period or after school.

5. **Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities,** as follows:

Parents may discuss with classroom teachers the best days and times for volunteering within the class. Parents are invited to attend and chaperone field trips as they are planned.
